Assessed Value Search

This line will be highlighted in yellow and is the equivalent of the property's gross assessed value as shown on the Notice of Assessment or Tax Bill.


Once you have entered information, click the "Search" button. To view an individual record, click the "Details" box. To view the information in an Excel file, click "Download."

The data contained in these searches come directly from each county, so the format in the database may vary. If your search is not yielding results, try a partial search by using just the street name without direction or type. (For example, if the address is "123 Main St.", try inputting "123 Main".) You can also try using part of your last name instead of your full first and last name. 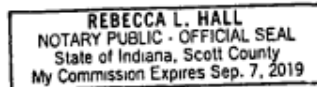
