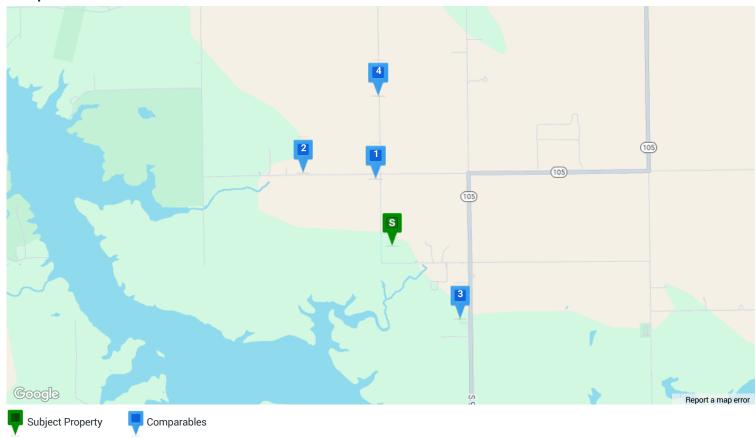

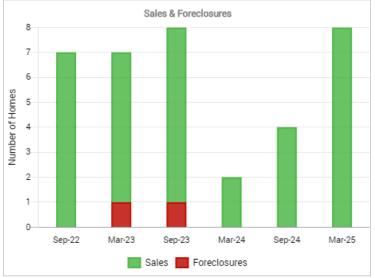

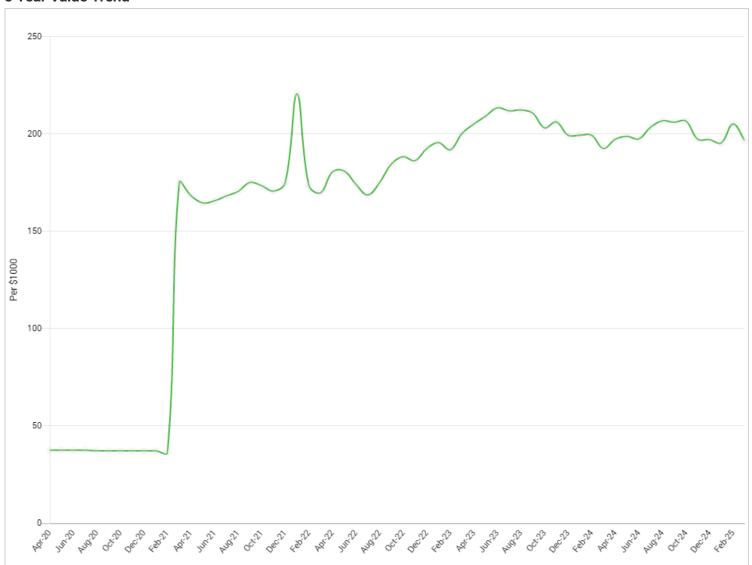
Market Trends - Andrews, IN (46702)
