Thank you for writing to Oliver Township with your request for information pursuant to the Pennsylvania Right-To-Know law.

On June 12, 2024, you requested electronic copy(s) of any open/pending or expired permits and demolition permits, codes violations, and advise if there are any unrecorded liens/fines or special assessments for tax parcel 200,060.00-028.000 address – 424 Daniel Rd, Newport, PA 17074, Owner: Estate of Paul Stahl.

I have searched the records of the township but have found no such documents for that parcel, and the owner stated is not correct. Your request is being denied under Pennsylvania Right-To-Know law, Section 705. Creation of Record.
