

Re: Request for public records to the City of Mount Rainier, Maryland

Dear Dhasarathi R.:

By email dated June 19, 2024, you have requested certain documents from the City of Mount Rainier. Specifically, you have asked for:

- 1. Any building permits, code violation & special assessment fees on record; and
- 2. The complete permit history, including all open and expired permits & Code Case or Active Code Lien & Special Assessment Fees Due or Outstanding found for 4034 34th St, Mt Rainier, MD 20712

The City responds to requests for records in conformance with the requirements of the Maryland Public Information Act (hereinafter, "PIA"), Md. Ann. Code, Gen. Provs. Art. ("GP"). Art., §4-101 *et seq*. The City has certain records responsive to these requests that it can disclose, and they are enclosed herewith.

You have asked that the City "provide general instructions to resolve any permits that are open, expired, or currently pose a concern to the property referenced above." The Maryland Public Information Act requires the City only to produce public documents in its possession that are responsive to your request and not privileged or exempt from disclosure.

You also asked for pending or active liens recorded on the property, and a payoff valid for 30 days from today's date. The City will not produce any records relating to liens on the property as they are documents relating to an individual's personal finances. See GP 4-336. Moreover, the City deems the production of these records to be an unwarranted invasion of personal privacy. See GP 4-103. The City will neither confirm nor deny that it has such records.

Pursuant to GP § 4-362, you are entitled to seek judicial review of the City's decision to withhold certain of the documents you requested. Alternatively, you may file a request for mediation with the Public Access Ombudsman and, if the Ombudsman is unable to resolve the matter, may subsequently seek a resolution from the Public Information Act Compliance Board for those matters within the Compliance Board's jurisdiction. See GP §§ 4-1A-01 et seq. and 4-1B-01 et seq.



(3) Under the authority of this section, any sworn police or code enforcement officer of the City of Mount Rainier may impound the abandoned or non-road-worthy vehicle, after attaching a notice on the presumed abandoned or non-road-worthy vebicle, which shall state, in part "the attached motor vehicle is presumed abandoned or non-roadworthy; if not removed or brought into compliance with section 6-116 of the General Ordinances of the City of Mount Rainier within10 days from the date upon this notice, this motor vehicle shall be impounded. Likewise, the motor vehicle owner will be liable for all towing, storage, preservation and all other charges related to the disposition of the motor vehicle."
