Description of Work:

Remove existing copper pipe in crawl space that is unstrapped and pulled down from previous plumbers. Leave recently completed repair preformed by other plumbing on copper pipe. Repipe kitchen lines using type L copper pipe. Repipe hot and cold mains down through crawl space. Route new copper pipe to existing CPVC mains at newly remodeled bathroom. Furnish and install Type L copper pipe and ProPress fittings. Furnish and install all necessary connection material. After water is restored any additional leaks will be repaired under this proposal. Furnish and install quarter turn service valves under kitchen sinks. Furnish and install any necessary quarter turn isolation valves. Provide drop clothes and runners to protect floors. Properly dispose of all jobrelated plumbing debris.
