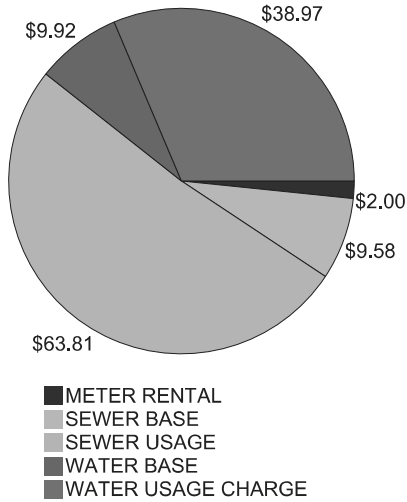

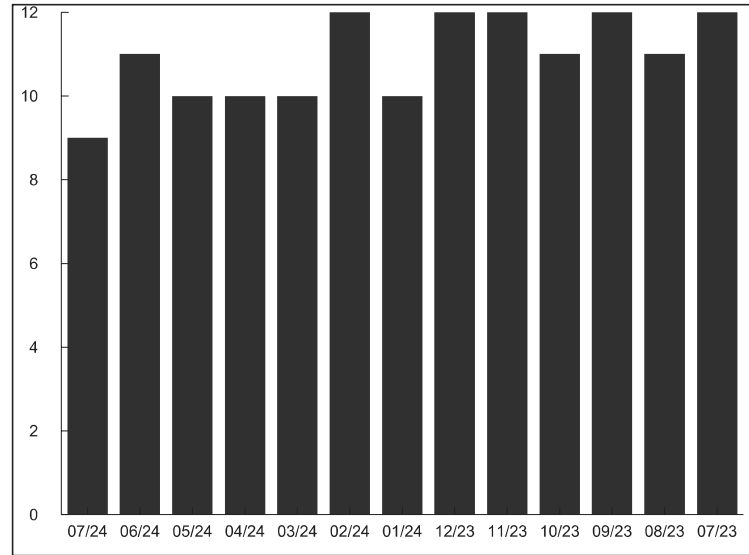

The property owner must keep the meter within their premises easily accessible for reading at all times. The owner will be held responsible for proper protection of the meter from all damage which may occur due to freezing or from hot water backing from over-heated house boiler or other causes.

The owner of the property shall pay, at the established meter rate, for amount of water registered, whether used or wasted.

Should a meter fail to register, for any cause, the quantity shall be determined and the charge made, based on average amount registered by the meter when in order.

No meter shall be disconnected from the pipe, moved or disturbed without permission from the Water Registrar, who will send a properly authorized person to attend to any change needed.

If not paid within 30 days from date of the bill, 10% (\$2.00 minimum) will be added to the water portion and sewer portion of the bill.

The property owner is responsible for a service charge of \$50.00 when the water supply is turned off and \$50.00 when the water supply is turned on.
