SINGLE FAMILY HOME RENTAL LAW

Homeowners who live in ISLANDIA have a vested interest in our community and this LOCAL LAW recognizes that. The concern has always been that an investor who does not live in our Village is not here to see what may be occurring on their property.

- If you are a Resident/Homeowner living in your home in the Village for a minimum of five (5) years, you may apply for a house rental permit. Accessory apartments are not permitted without a rental permit.
- Submitting an application does not guarantee a permit will be issued. Violations, tax arrears, police reports and complaints on file for the property will be taken into consideration.
- All rental permits are void when there is a transfer of property ownership. Change in tenancy requires a new permit application. All rentals are subject to inspections by the Fire Marshal's office as required.
- House rental permits must be renewed every year with a fee of \$1,000 per year. Rental permits for Condominiums and Townhouses are \$250 per year.
- The fine for renting a home without a permit is \$1,000 for the first offense and up to \$5,000 per offense thereafter.


