On January 2, 2025 the Township of Exeter ("Township") received your request dated December 27, 2024 (the "Request") for records pursuant to the Pennsylvania Right-to-Know Law, 65 P.S. §§ 67.101, et seq. ("RTKL").

The Request seeks, in pertinent part, the following: "30 Beecham Rd. Reading PA - Any open/pending/expired permits and demolition permits that needs attention and any fees due currently. Any code violations or fines due, any unrecorded liens/fines/special assessments due."
