We have received complaints regarding the accumulation of trash, junk & junk vehicles on your property at 1979 Timberline Ct. The accumulation of these items on your property is a violation of the Township's nuisance ordinance # 91-3. These items must be removed within 30 days of receipt of this notice. Failure to do so will result in legal enforcement of this ordinance.

Additionally, it was noticed that the outdoor wood burner appears to have been modified & the shielding has been removed. The shielding must be reinstalled on the unit within 10 days or the outdoor wood burner permit will be voided as per section 9 of the Outdoor fuel burning appliance ordinance 7-3.


