- 1. I serve as the Agency Open Records Officer ("AORO") for the Hopewell Township "Agency" and am responsible for responding to Right-to-Know requests filed with the Agency.
- 2. In my capacity as the AORO, I am familiar with the records of the Agency.
- Upon receipt of the request, I conducted a thorough examination of files in the possession, custody and control of the Agency for records responsive to the request underlying this appeal, specifically.
- 4. Additionally, I have inquired with relevant Agency personnel and, if applicable, relevant third-party contractors as to whether the requested records exist in their possession, specifically. The records that you have asked for only exist once the lien letter has been put together and researched from differing agencies.
- Based upon the above-described search of the Agency's files and inquiries with relevant Agency personnel, I have made the determination that the records requested are not within the Agency's possession, custody or control.

If there is a claim, the letter will provide the amount necessary to satisfy the claim(s). A Lien Letter Request Form must be completed and submitted for processing to the township well in advance of the set or anticipated closing date. Hopewell Township requires 10 business days for all sale or refinance transactions. The lien letter form is usually requested by a Title, Settlement Company or an attorney representing the sellers lien letter is \$20.
