Thank you for writing to the Office of Open Records ("OOR") with your request for information pursuant to the Pennsylvania Right-to-Know Law, 65 P.S. 67.101, et. Seq. requesting if there are any special assessments, open code violations open or expired permits recorded and or invoices/liens associated with 317 Revere Court, Coatesville, PA.

Your request for open code violations or pen/pending/expired permits or demolition permits is denied under Section 705 of the Right to Know Law ("Creation of Record") states "... an agency shall not be required to create a record which does not currently exist ...". Specifically, Valley Township does not have any open code violations or open/pending/expired permits and demolition permits for 221 Bardel Drive, Coatesville, PA.
