2. Make checks payable to **PEMISCOT COUNTY COLLECTOR**
3. Multiple Bills may be paid with one check
4. Non clearance of checks voids receipts
5. Bring or mail statement when paying
6. Mail early to avoid penalties. Postmark determines month of payment. Receipts will be returned by mail.
7. Statements are payable upon receipt. **Due in office or Postmarked by December 31st**
8. See penalty chart for correct amount due if paid or mailed after December 31st
9. NO ADJUSTMENTS WILL BE MADE FOR FAILURE TO RECEIVE A STATEMENT
10. RSMo 140.110 Mandates that all Delinquent taxes be paid BEFORE current taxes - call office for balance due.
