It is the obligation of each taxpayer to secure the proper tax bill or bills. Revised Code section 323.13.

Any increase in the amount of your current real estate tax must be attributed to valuation changes, tax levies, or bond issues. Your taxable value is 35% of the market value of your property. Any increase due to tax levies or bond issues was voted upon and passed by the voters of your taxing district. Your **COUNTY TREASURER** has no authority to increase your real estate bill.

Questions about values, special assessments, tax rate, homesteads, Non-Business Credit, Owner-Occupancy Credit, and farm reductions should be directed to the **Trumbull County Auditor's Office** - Phone: (330) 675-2420.

Notice: If the taxes are not paid within sixty days from the date they are certified delinquent, the property is subject to foreclosure for tax delinquency. Revised Code section 323.131(A)(3)(a).

When checks are not paid upon presentation at the bank, taxes will be marked delinquent and penalty plus interest will be added. Revised Code section 323.121.

A 10% penalty will be added to unpaid current net taxes after First and Second Half closing date.

An interest charge set by the Tax Commissioner will be added twice a year on unpaid delinquent taxes. These dates are the first day of the month following second half closing and December 1.

Beginning with tax year 2013 the ten and two and one-half percent rollbacks will no longer apply to new levies that are enacted after the August 2013 election. Levies that will continue to qualify for application of the rollbacks are levies approved at or before the August 2013 election, inside and charter millage as they appear on the 2013 tax list, renewals of qualified levies, and the substitute of qualified school district emergency levies under Revised Code section 5705.199.

Notice: If the taxes charged against this parcel have been reduced by the Owner-Occupancy Credit for residences occupied by the owner but the property is not a residence occupied by the owner, the owner must notify the county auditor's office not later than March 31 of the year following the year for which the taxes are due. Failure to do so may result in the owner being convicted of a fourth degree misdemeanor, which is punishable by imprisonment up to 30 days, a fine up to \$250, or both, and in the owner having to repay the amount by which the taxes were erroneously or illegally reduced, plus any interest that may apply.

If the taxes charged against this parcel have not been reduced by the Owner-Occupancy Credit and the parcel includes a residence occupied by the owner, the parcel may qualify for the tax reduction. To obtain an application for the tax reduction or further information, the owner may contact the county auditor's office at 160 High Street NW, Warren, OH 44481 or (330) 675-2420. Revised Code section 323.131(A)(3)(b).

If the real property for which this bill is issued is used as residential rental property and an owner's current contact information has not been filed with the county auditor, the required information must be filed with the auditor within sixty days of receipt of this bill. Failure to file the information or to update incorrect information in a timely manner may result in the assessment of a penalty of up to \$150 following each tax bill for which the information is not filed. See Revised Code sections 5323.01, .02 and .99 or the county auditor for more information.

If you are a member of the National Guard or reserve components of the U.S. Armed Forces who is called to active duty, or are the spouse or dependent parent of such member, you may qualify for an extension of time to pay your taxes. Please call the treasurer's office at (330) 675-2436 for details.

T.I.P. TAX INSTALLMENT PLAN
