PROPERTY TAX INFORMATION

The real estate of every person or corporation shall be responsible for all taxes as assessed against the owner. Bills are mailed to the last known owner. If you are not the present owner of this property, please forward this bill to the proper owner or return it to the Tax Collector's Office with the current owner's name, if known.

Questions relative to tax payments and balances should be directed to the Tax Collector at (603) 432-6106. Payment of this bill does not prevent the collection of previous unpaid taxes, nor does an error in the name of the person taxed prevent collection. Questions concerning assessments should be directed to the Assessor's Office at (603) 432-6104.

Cancelled checks are valid receipts for Federal Income Tax purposes. If a receipt is desired, please send the complete bill with payment and include a self-addressed stamped envelope.

The taxpayer may, BY MARCH 1st following the date of notice of the tax under RSA 76:16, apply in writing to the assessor(s) for an abatement of the tax. Qualified elderly and disabled taxpayers may also apply in writing for a deferral under RSA 72:38-a.

Abatement applications are available at the Assessor's Office in the Derry Municipal Center. Applications for abatements must be made in writing BY MARCH 1st following the date of mailing of the final tax bill, issued in the fall of the year (this constitutes NOTICE OF THE TAX), per RSA 76:16. The taxpayer has the burden to prove over assessment or inequity.

Filing an abatement application does not stop the collection of the tax, and it should be paid as assessed.

If you are elderly, blind, a veteran or veteran s spouse, or unable to pay taxes due to poverty, or other good cause, you may be eligible for a tax exemption, credit or abatement. Applications for exemptions and/or credits must be filed on or before April 15th each year. For details and application information contact the Assessor s Office at (603) 432-6104.
